### **KOCH INDUSTRIES NAMES FUTURE PRESIDENT AND CHIEF OPERATING OFFICER**

*Dave Robertson to become company's seventh president since 1940*

WICHITA, Kan. – Koch Industries, Inc. announced today that Dave Robertson will be the company's president and chief operating officer when its subsidiary Koch Forest Products, Inc. completes its merger with and into Georgia-Pacific. Following that merger completion, which is currently expected to occur on Friday, Robertson will become only the seventh president of the company since its founding in 1940.

Robertson, who has worked for Koch Industries and several of its subsidiaries for more than 21 years, will replace Joseph W. Moeller, who is set to become president and chief executive officer of Georgia-Pacific Corp.

“Dave Robertson is a proven leader who clearly exemplifies our guiding principles,” said Charles Koch, chairman and chief executive officer of Koch Industries. “His accomplishments in the past 20-plus years have significantly contributed to the success of Koch Industries. Exhibiting outstanding leadership, he has built teams that have captured many opportunities. The board and I believe that under Dave's leadership, Koch Industries and its subsidiaries will continue to create value and grow.”

Robertson was elected executive vice president and joined the Koch Industries board of directors in March. Before that, he was president of the company's petroleum and chemicals subsidiary, Flint Hills Resources. Robertson will continue to serve as chairman of the Flint Hills Resources board.

“Koch Industries' tremendous growth and success has been realized as a result of strong leadership and commitment from Charles Koch, Joe Moeller and many others who have contributed during the past 65 years,” Robertson said. “I am humbled by the confidence placed in me. With the help and advice of the many talented and experienced leaders within Koch companies, I hope to help continue the company's success into the future.”

Robertson joined Koch in 1984, working in sales and marketing for Koch Asphalt Company. From 1992 to 1996, he was with Koch Refining Group, including serving as the group's executive vice president of marketing. In the late '90s, Robertson became president of Koch Agriculture. In 2000, he was named president of Koch Petroleum Group, which became Flint Hills Resources in 2002.

Robertson earned a bachelor's degree from Emporia State University. He is a native of Olathe, Kan.
